PART 1: PRIVACY POLICY - PERSONAL INFORMATION AND PRIVACY

1. Introduction

- 1.1 At Esperanto Inc. DBA MarketLogic we are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat personal data collected from and other data gathering sources.
- 1.2 We will ask you to consent to our use of cookies in accordance with the terms of this policy when you first visit our website: mymarketlogic.com. By using our website and agreeing to this policy, you consent to our use of cookies in accordance with the terms of this policy.

2. Collecting personal information

- 2.1 We may collect, store and use the following kinds of personal information:
- a) information about your computer and about your visits to and use of this website (including, your IP address, geographical location, browser type and version, operating system, referral source, length of visit, page views and website navigation paths)
- b) information that you provide to us when registering with our website
- c) information that you provide to us for the purpose of subscribing to our email notifications and/or newsletters (including, your name and email address)

- 2. 3 The website is intended for use only by persons who are at least 18 years of age and who are fully able and competent to enter into and be legally bound by this privacy policy. Accordingly, we do not intend to collect personal information from anyone whom we know to be under 13 years of age.

3. Using your personal information

- 3.1 Personal information submitted to us through our website will be used for the purposes.
- 3.2 We may use your personal information to:

- a) send you email notifications that you have specifically requested
- b) send you our email newsletter, if you have requested it (you can inform us at any time if you no longer require the newsletter)
- c) send you marketing communications relating to our business which we think may be of interest to you, by post or, where you have specifically agreed to this, by email or similar technology (you can inform us at any time if you no longer require marketing communications)
- d) deal with enquiries and complaints made by or about you relating to our website
- e) keep our website secure and prevent fraud
- 3.3 If you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with the permission you grant to us.
- 3.4 We will not, without your express consent, supply your personal information to any third party for the purpose of their or any other third party's direct marketing.
- 3.5 Any communication or material you transmit to us by electronic mail or otherwise, including any data, questions, comments, suggestions, or the like is, and will be treated as, nonconfidential and nonproprietary. Except to the extent expressly covered by our privacy policy, anything you transmit, or post may be used by us for any purpose, including, but not limited to, reproduction, disclosure, transmission, publication, broadcast, posting and/or ranking. Furthermore, you expressly agree that we are free to use any ideas, concepts, know-how or techniques contained in any communication you send to us without compensation and for any purpose whatsoever, including but not limited to, developing, manufacturing and marketing products and services using such information.

4. Disclosing personal information

- 4.2 We may disclose your personal information to any member of our group of companies (this means our subsidiaries, our ultimate holding company and all its subsidiaries) insofar as reasonably necessary for the purposes set out in this policy.
- 4.3 We may disclose your personal information:
- a) to the extent that we are required to do so by law;
- b) in connection with any ongoing or prospective legal proceedings;

- c) in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk);
- d) to any person who we believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information.
- 4.4 Except as provided in this policy, we will not provide your personal information to third parties.

5. Retaining personal information

- 5.1 This Section 5 sets out our data retention policies and procedure, which are designed to help ensure that we comply with our legal obligations in relation to the retention and deletion of personal information.
- 5.2 Personal information that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes.
- 5.3 Notwithstanding the other provisions of this Section 5, we will retain documents (including electronic documents) containing personal data:
- a) to the extent that we are required to do so by law;
- b) if we believe that the documents may be relevant to any ongoing or prospective legal proceedings; and
- c) in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).

6. Security of your personal information

- 6.1 We will take reasonable technical and organizational precautions to prevent the loss, misuse or alteration of your personal information.
- 6.2 We will store all the personal information you provide on our secure (password- and firewall-protected) servers.
- 6.3 You acknowledge that the transmission of information over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

PART 2: COOKIES POLICY

1. About cookies

- 1.1 A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.
- 1.2 Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

- 1.3 Cookies do not typically contain any information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.
- 1.4 Cookies can be used by web servers to identify and track users as they navigate different pages on a website and identify users returning to a website.
- 2.1 We use both session and persistent cookies on our website.
- 2.2 The names of the cookies that we use on our website, and the purposes for which they are used, are set out below:
- a) we use performance cookies on our website. These cookies enable the collection of information about how visitors use our website, including which pages visitors go to most often and if they receive error messages from certain pages. These cookies do not collect information that individually identifies a visitor. All information these cookies collect is aggregated and anonymous. It is only used to improve how mymarketlogic.com functions and performs.
- b) we use functional cookies on our website to allow **us** to remember information you have entered or choices you make and provide enhanced, more personal features. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can customize.
- c) we might use third-party service providers to serve advertisements on our behalf across the Internet. These service providers may collect your IP address and non-personally identifiable information about your visits to our site in order to serve MarketLogic ads while you are visiting other websites. Such non-personally identifiable information is anonymous and does not include your name, address, email address or other personal information, however, your IP address may be collected. The anonymous information is collected through the use of a pixel tag (also known as cookies and action tags), which is the industry-standard technology used by most major websites.

3. Analytics cookies

- 3.1 We use Google Analytics to analyze the general traffic and use of our website as well as to track individual behavior on our website e.g., completing a form, opening an email, clicking a link and web page visits on our website.
- 3.2 Our analytics service provider generates statistical and other information about website use by means of cookies.
- 3.3 The information generated relating to our website is used to create reports about the use of our website.

4. Third party cookies

These other websites, services and applications may set their own cookies on users' computers, collect data, or solicit personal information. 5. Blocking cookies

- 5.1 Most browsers allow you to refuse to accept cookies, for example:
- (a) in Internet Explorer (version 10) you can block cookies using the cookie handling override settings available by clicking "Tools", "Internet Options", "Privacy" and then "Advanced";
- (b) in Firefox (version 24) you can block all cookies by clicking "Tools", "Options", "Privacy", selecting "Use custom settings for history" from the drop-down menu, and unticking "Accept cookies from sites"; and
- (c) in Chrome (version 29), you can block all cookies by accessing the "Customize and control" menu, and clicking "Settings", "Show advanced settings" and "Content settings", and then selecting "Block sites from setting any data" under the "Cookies" heading.
- 5.2 Blocking all cookies will have a negative impact upon the usability of many websites.
- 5.3 If you block cookies, you will not be able to use all the features on our website.

6. Deleting cookies

- 6.1 You can delete cookies already stored on your computer, for example:
- (a) in Internet Explorer (version 10), you must manually delete cookie files (you can find instructions for doing so at http://support.microsoft.com/kb/278835);
- (b) in Firefox (version 24), you can delete cookies by clicking "Tools", "Options" and "Privacy", then selecting "Use custom settings for history", clicking "Show Cookies", and then clicking "Remove All Cookies"; and
- (c) in Chrome (version 29), you can delete all cookies by accessing the "Customize and control" menu, and clicking "Settings", "Show advanced settings" and "Clear browsing data", and then selecting "Delete cookies and other site and plug-in data" before clicking "Clear browsing data".
